



CITY OF MANTUA TOURIST TAX

THE MUNICIPALITY OF MANTUA HAS ESTABLISHED THE TOURIST TAX FROM JANUARY 1ST, 2018. THE CITY COUNCIL DECISION N. 82 ON 20.12.2018 APPROVED THE NEW REGULATION FOR THE APPLICATION OF THE TOURIST TAX, IN FORCE SINCE JANUARY 1ST 2019 TO MARCH 31ST 2024. WITH THE DECISION N. 74 ON 19.12.2023 THE CITY COUNCIL APPROVED THE NEW REGULATION FOR THE APPLICATION OF THE TOURIST TAX, IN FORCE SINCE APRIL 1ST 2024. THE CITY COUNCIL DECISION N. 276 ON 20.11.2023 ESTABLISHED THE RATES STARTING FROM APRIL 1ST 2024.

INFORMATION FOR GUESTS

TAX PURPOSE

This tax is intended to finance tourism actions, including those for preserving and improving the artistic heritage of the city, for organizing and carrying out cultural events and for improving of local public services

AMOUNT TO BE PAID

The tax is due per person per night, up to a maximum of five nights (until March 31st 2024) or seven nights (starting from April 1st 2024), even non-consecutive, in the same month and in the same accommodation, except for those who are exempted. For campsites and pitch for tents areas, the tax is due by overnight stay for a pitch area or for the tent's storage.

WHO PAYS THIS TAX

Non-resident visitors spending one or more night in one of the accommodation facilities located in the municipal area must pay the tourist tax. The tax must be paid to the owners/managers of the accommodation facility, which must provide a receipt of payment to the guests.

WHO IS EXEMPTED FROM PAYING THE TAX

- A** The officially registered residents at the registry office of the Municipality of Mantua.
- B** Children under the age of 14 years old, if they lodge with at least an adult person, except for minors who are part of the groups organized by schools for educational trips.
- C** Coach drivers and tour guides who assist organized group trips. The exemption is applied for each bus driver and for one tour guide every 20 paying tourists. The exemption applies to all bus drivers of groups of 20 participants and to one tour guide for every 20 participants.
- D** Personnel employed by the State Police and other Armed Forces performing activities of public order and safety (as defined in the Consolidated Text of Public Safety). The exemption is applied only when the stay is paid directly by the respective public authority or in case the service reasons are proved.
- E** Disabled persons who are not self-sufficient with appropriate certification and their assistant.
- F** The Municipality of Mantua in the event of lodging expenses paid by the Municipality itself.
- G** The employees of the accommodation that spend the night at the property itself.
